## Category of work: Healthcare.

#### <u>Criteria</u>

- Individual, individual, family, family foundation, private foundation, a special purpose philanthropy group or group of individuals, entrepreneur or NGO, should have demonstrated extraordinary care for civic society with charitable aim.
- $\cdot$  The demonstrated work should solve some of the most pressing societal issues, to create model institutions and inspire others.
- Individual whose generosity inspires others for upliftment of the deprived.

#### **Process**

- Nominee to give all details in 1000 words
- Nominee to mention contact details
- Mention category of work
- $\cdot$   $\,$  Mention name of initiative/s undertaken which made impact or brought difference to Civil Society
- · Describe the charitable activity/ activities undertaken
- · Describe the impact made by your initiative/ initiatives directly or indirectly

## **GAPIO Life Time Achievement Awards**

**The GAPIO Lifetime Achievement Award** shall be given to an outstanding doctor to recognize his/her exceptional contributions to healthcare throughout his/her career.

- The nominee should be a well-known scholar, researcher, clinician or academician.
- He/ She should have at least 35 years of experience in the healthcare.
- He/ She should have demonstrated outstanding leadership in India or overseas.
- He/ She should have contributed towards public awareness on healthy living or made a significant contribution to improve social services and general public health, improving quality of life in the community.
- Dr. B. C. Roy Award, Padma Shri, Padma Bhushan, Padma Vibhushan Award or other international awards will be an added qualification.

- EC member shall not apply for GAPIO Lifetime achievement award.
- EC member shall not nominate any person for GAPIO Lifetime achievement award.
